## Inquiry hearings start this month

The Infected Blood Inquiry will begin its hearings in London at the end of this month.

As promised by Inquiry chair, Sir Brian Langstaff, it is the people infected and affected by the contaminated blood scandal whose voices will be heard first.

Personal testimonies are due to be heard throughout the first phase of the Inquiry hearings, which will last until October 2019.

The Inquiry will initially sit at Fleetbank House in London for two weeks before moving to Belfast, Leeds, Edinburgh and Cardiff to hear evidence from around the United Kingdom.

The Inquiry will sit four days a week and hopes to hear evidence from three people a



day. There will also be the chance for those infected and affected to give evidence at the end of the Inquiry.

Sir Brian has confirmed that he is reading every written statement submitted to the Inquiry and says he has little doubt that the testimonies will help to “get to the truth” of what happened.

## Inquiry must flush out the truth, says chair of trustees



The Society's chair of trustees, Clive Smith, has urged The Infected Blood Inquiry to stop at nothing to uncover the truth about the contaminated blood scandal.

In an open letter to members, Clive calls for a light to be shone on government, pharmaceutical companies and public health organisations so that the truth can finally be uncovered. He said The Haemophilia Society also accepted and welcomed scrutiny of its role.

He said: "Everything must be exposed, because only then can our community begin to look to the future, rather than backwards at a dark past."

Clive, who plans to attend as many of the Inquiry hearings as possible, described growing up with severe haemophilia A in the shadow of the contaminated blood scandal.

He said: "Like many of you, I have lost friends and peers to this treatment disaster that should never have happened and for which no one has ever been held accountable."

In his letter Clive said that the scandal had torn apart thousands of lives and that it was important this was recognised by the Inquiry.

He said: "We know that for many, both living and dead, justice will never be achieved. No apology will ever suffice and no recompense can take away the heavy burden that has been carried by so many, for so long. The anger at the lies that had to be told and the shame that had to be endured cannot be washed away."

Clive, who joined The Society's board of trustees in 2015 and became chair last year, also said that the scandal had made the haemophilia community more cautious about new developments in treatment.

He stressed the need to learn lessons from the findings of the Inquiry to ensure that any risks associated with new treatments are fully understood.

He concluded: "The outcome of this Inquiry cannot undo the past, but it can and must expose the truth behind this scandal and bring those responsible to account."

Peter Jones, who will be leading The Society's legal team at the Infected Blood Inquiry, has been a partner in Eversheds Sutherland for more than 30 years. He is supported by Angharad Shurmer, Principal Associate at Eversheds Sutherland. Peter set up the firm's Inquiries and Investigations Team more than 20 years ago and has been involved in many of the UK's most high profile public inquiries.

He said: "My team goes into this public inquiry with an understanding of the process that's going to unravel the facts of the contaminated blood scandal and, we hope, provide those infected and affected with the answers for which they have waited so long.

But we start by listening. We weren't there, we need to be told."

Peter and his team have worked on a number of public inquiries in the UK, including the Bloody Sunday Inquiry, the Shipman Inquiry and the Jersey Care Inquiry, into child abuse.

He believes this gives them an invaluable insight into how public inquiries work. He said: "What we bring to The Society is an experience of knowing what the Inquiry will expect of it and an understanding that an inquiry will be best served by an approach of openness, accountability and assistance. I hope we will enable The Society to engage meaningfully with the Inquiry in a way that recognises the history of what it has done and advised in the past. It is history, it can't be undone, but lessons can be learnt."
